#### 5. Mayor's Comments.

- a) Small Town Mayor's Meeting to be hosted by Weston Lakes On January 4, 2010. Normally only attended by the Mayor's and Mayor Pro Temp, but the Mayor invited the Weston Lakes City Council so they could meet mayors from surrounding towns.
- b) The Mayor contacted 8 local banks about their current CD rates to invest \$30,000 of the money currently in the city's checking account. Rates are very low at the moment, running from 0.99% -1.74%. She recommended more work be done before making those investments.
