

Minutes of Meeting
City of Weston Lakes Emergency Management Committee Meeting

1. Meeting called to order by Chairman Cliff Aldrich at 6:00 p.m.
2. Approval of Minutes of the 14 August 2012: Approval tabled for lack of a quorum.
3. Chairman's Comments:
 - *Storm Siren Grant Status: Grant is still with FEMA. Concerns within the community surrounding installation of Storm Warn Siren include monitoring, administration, locations, etc.
 - *Storage Building: We have obtained, located and loaded the storage container with EMC supplies and equipment. City Adopt -a-Highway materials will also be stored in the container. Four keys will be distributed to Chairman Aldrich, Mayor Zdunkewicz, Operations Chief Trent Thomas and Logistics Chief Denis Deluca
 - *Public Health: Only 20 days remain of Hurricane Season: chances are at a low 10% for an event to develop. West Nile Virus: Mosquito borne disease; no cases reported in Weston Lakes. The County is testing within The City and to date all tests are negative. Cases (13) have been reported in Fort Bend County, the most persistent pool reporting positive and still being treated is in Pecan Grove. Dallas County has reported numerous cases, some resulting in deaths. Public education in Weston Lakes will limit the breeding of mosquitoes.
 - *Intercom Radios: Radios have been purchased; headsets were not compatible and have been returned. Alternatives being researched. The use of the intercom radios will enhance communication within the EOC and at the same time, reduce the noise level within the EOC.
4. Training: 2012 Nimcast. Chairman Aldrich reported our Report was submitted on 27 August to the County and then on to the State of Texas.
5. Training: 2012 Requirements: Chairman Aldrich presented the Training Matrix and gave a general review of Training requirements. Compliance is due by September 2013. The City is at about 50% compliance presently. It was also reported the Fort Bend County Fire Department has volunteered space to hold training for all to attend.
6. Exercise After Action Review: Chief of Operations, Trent Thomas presented an outline summary of the

25 August Full Scale Exercise. Chief Thomas requested all members to review and be ready to comment at the next EMC meeting. Summary Attached.

7. Debris Management: Chairman Aldrich reported our plan has been submitted to the City Council of Weston Lakes for Action/Adoption. Additionally, our Mitigation Plan is nearing final modifications and will go to Commissioners' Court.
8. Comments: Visitors, Everett Dyer and Rich Lannin were introduced and invited to join the committee. General introductions of the members present was also included. Trent announced the County's compliments to Weston Lakes on its EMC and thanked Chairman Aldrich for all his work in this accomplishment. It was announced that Nov 17 is the Veterans Dinner. Trivia Night is every other Thursday at the CC Courtyard. Chairman Aldrich reported on the satisfactory recovery of the Mayor since her fall a few weeks ago and further commented on her devotion to Weston Lakes and its residents calling her the "Grand Lady of Weston Lakes". Prayers/thoughts were requested for Vern and Carolyn Flowers: Vern suffered a heart attack/by-pass surgery.
9. Adjournment: Chairman Aldrich adjourned the meeting at 7:03 p.m.
